SIGNS OF THE TIMES: THE GOOD, THE BAD, THE UGLY, AND THE RIDICULOUS

Attorney Robert C. Cetrulo, President of Northern Kentucky Right to Life, presented his legal research paper, "Euthanasia: Hell's Last Sacrament," at the **annual conference of the University Faculty for Life** held at St. Thomas University School of Law in Minneapolis last month. UFL is a national organization consisting of persons from multiple educational disciplines who have taught at the college level and are active in the Pro-Life movement.

** ** **

Dr. John Bruchalski, founder of the **Tepeyac Family Center** in Fairfax, Virginia, has spoken out against the **Department of Health and Human Services proposal to rescind a conscience protection regulation for healthcare workers**, stating that it would force him to perform abortions, or at the very least refer patients to other people who offer that procedure. Bruchalski was joined by 40 other doctors, anesthesiologists, physician assistants, pharmacists, and nurses who packed the press conference to address their concerns about this issue which has resulted in 36,000 filed oppositions to the proposed change, proposed by the Obama administration.

Dr. David Stevens, CEO of the **Christian Medical Association**, told reporters that his group had sent Obama a letter detailing its concerns about this proposal: "This issue isn't just about abortion. Right of conscience will become increasingly important with other healthcare issues looming ahead: euthanasia, genetic engineering, human cloning, and more."

** ** **

President Obama "quietly" canceled the **National Day of Prayer** celebration on the White House lawn, which had been promoted for the past eight years under President Bush. The item gathered sparse coverage in the secular media, but Obama's excuse was that he would "pray privately" that day.

** ** **

All 30 major league baseball teams teamed up on the middle Sunday of May with the **Susan G. Komen Race for the Cure** organization to recognize "fans who are going to bat against breast cancer in their daily lives." No mention was given to the fact that the **Komen Foundation makes substantial annual contributions to Planned Parenthood, which of course is the main promoter of the abortifacient pill, which has been found by many studies (including one commissioned by the Komen Foundation itself) to increase breast cancer!**

Brings to mind the paradox of the U.S. attorney general condemning smoking, as a cause of lung cancer, while the Agriculture Department subsidizes the growing

of tobacco! At some point, stupidity is transcended into frank evil! At least in the tobacco situation, the taxpayers are not voluntarily subsidizing cancer.

The Komen Foundation has now come out in favor of embryonic stem cell research funding.

The last battle in America's culture wars took place in May at Miami University, Oxford, Ohio, which hosted a **national conference of "Scholars of Human Sexuality,"** who want us to "rethink" how public school children learn about sex. The two dozen advocates want to "affirm the okayness of the sexuality of all young people, as well as different sexual identities and orientations," according to literature announcing the conference. They say school programs based on sexual abstinence are unrealistic options whose time is past. The conference, sponsored by **National Summit on Youth Culture, Popular Culture, and Sexuality Education**, is carrying out a two-year study paid for by the **Ford Foundation**.

** ** **

Four new dramatic opinion polls taken in May (and almost totally ignored by the secular media) show that Americans are taking a dramatic turn towards greater opposition to abortion. The annual Gallup Values and Beliefs Survey found that a majority of Americans (51 percent) describe themselves as "pro-life" with respect to the abortion issue, while only 42 percent said that they were "pro-choice." This was a shift of seven to eight percentage points from a year earlier.

A spokesman attributed the Pro-Life shift to greater public awareness about abortion and public policy, especially because of "the debate and action around the Freedom of Choice Act," and the recent campaign to keep conscience protections in place for healthcare workers who oppose abortion.

Fifty-two percent of the Catholic respondents and 59 percent of Protestants described themselves as Pro-Life in this most recent poll. Seventy percent of Republicans said they were Pro-Life compared to 60 percent in 2008, and the percentage of pro-choice Republicans dropped from 36 percent in 2008 to 26 percent this year. Democrats and independents who lean towards the Democratic party had their positions remain virtually unchanged, with 61 percent saying they were pro-choice and 33 percent Pro-Life in 2009, compared to 60 percent pro-choice and 33 percent Pro-Life last year.

** ** **

American Life League reported that employees of the **Commonwealth of Catholic Charities** in the Diocese of Richmond, Virginia, helped a teenage immigrant get an abortion last year, and no one did anything to stop it – including the executive director of Catholic Charities and the diocesan bishop, **Francis X. Di Lorenzo**, who subsequently wrote a confidential letter of apology to his brother bishops apologizing and acknowledging the fact

that **Catholic Charities of Richmond (CCR)** was complicit in authorizing, procuring, and paying for this abortion in January of 2008.

** ** **

A new study conducted by the **Program on Public Values at Trinity College in Hartford, Connecticut**, has demonstrated that secularism continues to grow and Christianity shrinks in all regions of the United States.

** ** **

The **Presbyterian Church (U.S.A.)** laid off 14 employees from its Louisville headquarters in March and another 14 people since September, which it ascribed to recession and long-planned restructuring. The newspaper article went ahead to recount that even before the recession, the church had experienced long-term declines in funds from member churches, resulting in several rounds of job cuts in recent years, including 75 layoffs in 2006: "Controversies over theology and homosexuality have also prompted some churches to reduce their funding or leave the domination altogether."

** ** **

According to a four-year study conducted by the **Presidential AIDS Commission**, the use of condoms resulted in a 24 percent failure rate. In another study reported by **Dr. Margaret Fishel** to the **International Conference On AIDS**, married couples with one HIV-free partner using condoms for protection, tested HIV positive in 17 percent of the cases after only one-and-a-half years.

The nations with the highest rate of condom availability – South Africa, Kenya, Botswana, and Zimbabwe – have the highest rates of HIV infection. Uganda, the country with the lowest rate of condom availability, has by far the lowest incidence of AIDS in the region. It once had the highest rate of AIDS in the world, but in the late 1980s the Uganda government chose to follow a different approach, promoting abstinence before marriage and fidelity during marriage, the path recommended by the Catholic Church, instead of handing out condoms. From 1991 to 2001, the incidence of AIDS in the population of Uganda dropped from 15 percent to 5 percent, whereas the disease rose in Botswana to 38 percent and in Zimbabwe to 32 percent by 2001, and both have risen since then.

** ** **

U.S. Sen. Arlen Specter of Pennsylvania (privately called by many in both parties "Specter the Defector") shocked many with his sudden announcement in April that he was leaving the Republican Party to join the Democrats. This decision came promptly upon the publication of a poll showing that he would lose in the upcoming Republican primary for reelection in Pennsylvania to **Republican Congressman Pat Toomey**.

Specter barely defeated Toomey six years ago in the Republican primary for that Senate seat. He had

the support of President George W. Bush and fellow U.S. Senator from Pennsylvania, Rick Santorum, who claimed of course to be a strong Pro-Lifer, but in fact supported the radical pro-abortionist Specter with the justification/excuse that they were fearful that if Toomey defeated Specter, they would lose the seat to a Democrat. That is now what has happened with Specter's defection to the Democratic Party.

It was not Specter's first defection. He started his political life as a Democrat, and then joined the Republican Party in 1966 after running against his boss and getting elected Philadelphia District Attorney, and has now defected again, this time from the GOP back to the Democrats, showing another opportunistic move by one of the most opportunistic politicians of modern times. As a footnote, Santorum was dramatically retired by the voters in his last reelection effort in Pennsylvania, with the Pro-Lifers appropriately abandoning him for his lack of fidelity to principle.

In typical political hypocrisy, the **Democratic leader of the Senate, Harry Reid**, stated: "I have known Sen. Specter for more than a quarter century. He has always been a man of honor and integrity, and a fine public servant," which seems to contradict what Reid wrote in his 2008 biography that Specter, who was known to cross over from the Republican Party, of which he was then a member, and vote with the Democrats, "is always with us when we don't need him."

The December 2008 survey completed by **American Life League** demonstrates that **Planned Parenthood facilities in the United States (PPFA) has decreased its total number of surgical abortion facilities, but increased the number of facilities that perform medical (chemical) abortions.** The decrease in their local affiliates since 2007 has resulted in a cut of their overhead and an increase in their overall profits.

** ** **

Ignorance reigns supreme across our land, according to a recent article by **Walter E. Williams**, a professor of economics at **George Mason University** and a black syndicated columnist, as he recounted the Delaware-based Intercollegiate Studies Institute's recently released study, "**Our Fading Heritage: Americans Fail a Basic Test on Their History and Institutions.**"

Only 21 percent of those surveyed knew that the phrase "government of the people, by the people, and for the people" comes from President Lincoln's Gettysburg Address. Almost 40 percent incorrectly believe the Constitution gives the president power to declare war. Only 27 percent know that the Bill of Rights expressly prohibits establishing an official religion for the United States. Only 50 percent understood that there are three branches of government – the Executive, Legislative, and Judicial.

Williams points out that a 1999 survey taken by American Council of Trustees and Alumni of seniors at the nation's top 55 liberal arts colleges and universities found that 98 percent could identify rap artist Snoop Dogg and Beavis and Butt Head, but only 34 percent knew George Washington was the general at the Battle of Yorktown.

** ** **

According to the **Guttmacher Institute**, which compiles reproductive health statistics for **Planned Parenthood, black women abort their children at five times the white rate and twice the Hispanic rate.** (It is no accident that PPH locates its abortuaries in inner-city areas where the black community is concentrated, in accord with the genocidal principles established by its founder, **Margaret Sanger.**)

** ** **

What reduces abortions? You will see it repeated in the pro-abortion press that abortion rates declined dramatically during the Clinton years but stopped during the Bush administration. The reality is that the abortion rate has dropped 30 percent from 1981 to 2005, the decline starting 12 years before Clinton took office and has continued fairly steadily to the present day. The decline is most steep among minors.

It is not possible that economic factors reduced abortions for teens but not their older sisters, or their mothers who support them. The reality is that in 1980, the Supreme Court upheld the **Hyde Amendment** and federally funded abortions went from 300,000 a year to nearly zero. The Supreme Court decisions upholding other abortion restrictions (*Webster*, 1989, and *Casey*, 1992) upheld state-passed laws restricting abortion – bans on the use of public funds and facilities, informed consent laws, parental involvement when minors seek abortion, etc.

The proposed **Freedom of Choice Act (FOCA)**, advocated by Obama, would totally destroy these state and federal statutes which have reduced abortions.

Brings to mind the old aphorism that figures don't lie, but liars figure.

OBAMA = PLANNED PARENTHOOD'S BIGGEST POLITICAL SUPPORTER = BLACK GENOCIDE

The pro-abortion movement attacks black families the most, according to Dr. Alveda King, the niece of Dr. Martin Luther King, Jr., who noted that it is no coincidence that 78 percent of Planned Parenthood abortuaries are in African-American neighborhoods: "I know in my heart that if Uncle Martin were alive today, he would join with me in this greatest civil rights struggle of this generation – the recognition of the unborn child's

basic right to life. Injustice anywhere is a threat to justice everywhere."

"Taking more African American lives than gun violence, heart disease, cancer, and AIDS combined, abortion seems to have targeted blacks in a way that can only make remaining Ku Klux Klan members smile. For every three living African Americans, there is one who has been aborted. It's as if a plague swept through the black community and took every fourth person.

"The racism in Planned Parenthood's history is undeniable. America's largest abortion provider was founded by Margaret Sanger, a woman who wanted what she termed 'more children from the fit, less from the unfit.' She once described aboriginal Australians as 'just a step higher than the chimpanzee in brain development.' She had no problem speaking to a Klan meeting.

"That racism still exists in Planned Parenthood is also undeniable. Earlier this year in taped conversations, seven different Planned Parenthood offices across the country were willing to accept donations for the sole and explicit purpose of aborting black babies — until their willingness to accept those donations was exposed."

HELPERS MINISTRY EXPANDS

Helpers of God's Precious Infants Prayer Vigil for Life, which was begun more than 12 years ago by a small cadre of longtime prayer witnesses before the Planned Parenthood abortuary in Mt. Auburn, begins with 8:00 a.m. Mass at **Holy Name Church**, Auburn and McMillan Avenues, Cincinnati, followed by a Rosary Procession to the Planned Parenthood abortuary two blocks away. It began with one Saturday a month and has now extended its operation to the first four Saturdays of every month.

Soon it will be extending its outreach to the west side of Cincinnati, at the specific invitation of **Fr. Thomas L. Bolte**, Pastor of **St. Teresa of Avila Parish**, 1175 Overlook Avenue, Cincinnati, Ohio. **Beginning on Saturday, September 12, and monthly thereafter on the second Saturday of every month, the prayer and witness location will be changed to St. Teresa of Avila Church, with Mass beginning at 8:30 a.m.**, followed by a Rosary Procession to the Planned Parenthood clinic there in Price Hill.

The format will remain the same in Mt. Auburn, with Mass being celebrated on the first, third, and fourth Saturdays of every month at 8:00 a.m., followed by a Rosary Procession to the Planned Parenthood abortuary there on Auburn Avenue.

On the second Saturday of every month, beginning on September 12, there will be no Helpers Mass at Holy Name Church, but there will be a Rosary prayer witness conducted in front of the Auburn

Avenue abortuary by Fr. James Bramlage, Pastor of St. Nicholas Parish of Sunman, Indiana, and his faithful group of parishioners, which will begin at 9:30 a.m.

The Helpers movement is extremely excited about expanding its outreach and witness to another community in Cincinnati and touching yet more people needed to storm the gates of Heaven with prayer to remove the debacle of death, abortion, from our land.

MANDATORY FUNDED ABORTION COVERAGE IN HEALTHCARE BILL

LifeSiteNews.com reports: In a CBS Evening News interview yesterday evening, President Obama dodged a question on his position regarding taxpayer-funded abortion coverage in the healthcare bill, saying only that concerned citizens should not get "distracted" with the contents of the new healthcare's essential package.

Despite Obama's dismissal of the issue, the warnings of Pro-Life groups and lawmakers decrying the "FOCA by stealth" hidden in the healthcare overhaul have spread rapidly across the nation in recent days, and are increasingly attracting the notice of the mainstream media.

Pro-Life lawmakers in both the House and the Senate have offered several amendments that would have explicitly excluded abortion from the bill, as well as protect conscience rights of doctors objecting to abortion. All such amendments were rejected.

EARLY ABORTIONS DONE BY PILLS

One in four early abortions are now done by pills, not surgery, according to a recent study published in the *New England Journal of Medicine*.

The process involves two pills, the first ingested at a doctor's office, which causes the unborn child to be detached from the mother's uterine wall. A second pill is then used one to two days later to cause contractions and deliver a dead baby. This advancement of killing has been found to be 98.5% effective, and has supposedly "reduced" health risks to the mother, although the abortion industry is careful not to disclose actual medical problems or numbers. Be certain that it will have serious consequences to women, as all such unnatural acts do.

Mae's death unavoidably brought to mind the beautiful thought expressed by that great Pro-Life **Congressman Henry J. Hyde** (now deceased himself), who described what he believed would be the same greeting faithful Pro-Lifers receive at the end of their life: "I also believe that those who have worked in the pro-life movement will not be alone. They will hear a chorus of voices that were never heard in this world, but are heard beautifully in the next world — and they will plead for everyone who has been in this movement. They will say to God, 'Spare them, because they loved us very much,' and God will look at us and ask not 'Did you succeed?' but 'Did you TRY?'"

While we must of course pray for Mae, a flawed human being like all of us, many are comforted in the belief that she has received the words of greeting described in **Matthew 25:34**: "Come, you who are blessed by My Father, says the Lord, inherit the kingdom prepared for you from the foundation of the world."

And while we will miss Mae's cheery and prayerful presence standing at the abortuary gates each Saturday, we know that she now undoubtedly continues her prayer efforts for the sanctity of all innocent human life, at the pearly gates themselves - the gates of Life.

Those who were fortunate to attend her wake and/or funeral service were treated to the remarkable spectacle of the true beauty of God's plan, in their viewing of her 13 children, 71 grandchildren, 158 great-grandchildren, and 60 great-great grandchildren, whose lives sprung from the physical loins and spiritual fidelity of this holy woman.

Sprinkled throughout the crowd of other admiring Pro-Lifers were multiple members of **Cincinnati Right to Life**, **Northern Kentucky Right to Life**, **Old St. Mary's Problem Pregnancy Center**, and **Helpers of God's Precious Infants Ministry** (including Mae's daughter, Jo Ann Engle, a founding member of Helpers), all of which had been beneficiaries over the years, in a variety of ways, of Mae's limitless charity and undaunted dedication. The crowd included **Ray and Jonie Loebker**, early pioneers of the sidewalk counseling movement there at the abortuary, and Cincinnati attorneys **James Condit** and **Thomas Condit**, who had selflessly and voluntarily defended Mae and her other peaceful pickets on numerous occasions. On one occasion, where they were illegally arrested and kept in jail overnight, Jim succeeded in having the charges against them dismissed and then, like everyone who challenges the Devil and his earthly minions, felt the sting of persecution as he then was fined (improperly) by the Federal District Judge in Cincinnati. Condit then engaged the volunteered services of attorney **Robert C. Cetrulo**, President of NKRTL, and a successful appeal was prosecuted in the U.S. Court of Appeals for the Sixth Circuit at Cincinnati. This case resulted in an

important published judicial opinion establishing the rights of peaceful protestors on the sidewalks in front of the abortuary, which continue now even unto this day more than 20 years later with crowds of between 100 and 200 peaceful and prayerful witnesses for life participating in the prayer liturgy there four Saturdays a month, changing hearts and minds, and storming the very gates of heaven with prayer, for the babies, their parents, and the abortionists themselves.

Deacon David Shaffer, who gave the scriptural readings and homily at her funeral, recounted a delightful story about this gentle lady which was known to many. On one occasion of her arrest, police officers, not wishing to cause injury to the wrists of this gentle grandmother, affixed the handcuffs lightly, and as they were going down the line handcuffing others, Mae's cuffs dropped off with a clatter to the sidewalk, to the profound consternation of the Deathscorts at PPH, who clamored for her immediate restraint. Mae simply leaned over and picked up the handcuffs and put them back on herself, smiling sweetly, as she always did.

ANOTHER ADVOCATE BEFORE THE THRONE OF GOD - MAE BREADON

Mae Warner Breadon, quite literally the Godmother of the Pro-Life movement locally, died on April 25, 2009. While we all feel the loss acutely, she has clearly ascended to a higher Pro-Life advocacy position in front of the very throne of God.

Mae's encouraging smile was a welcome respite for all of us, and was ever present at all Pro-Life functions. She is perhaps most well known for having inaugurated the prayer witness movement in front of the Planned Parenthood abortuary on Auburn Avenue in Cincinnati for many years. She was a founding member of **Helpers of God's Precious Infants** movement which formally began 13 years ago, although her prayer activities there at the clinic had been going on for many years with a small cadre of others. Mae's earlier activities there included participation in the Rescue Movement, wherein peaceful prayer warriors interposed their bodies by peacefully sitting in on the steps of the abortuary, interposing themselves between the victims (children and mothers) and their executioners in the abortuary. She was one of many who suffered multiple arrests and wore proudly as a badge of honor the title "Jailed for Life." (This story continues on Page 7.)

CELEBRATION FOR LIFE SUNDAY, SEPTEMBER 20, 2009 GUEST SPEAKER: BOBBY SCHINDLER, Executive Director of the Terri Schindler Schiavo Foundation



"I keep praying that somebody does something because I'm frightened that people will come and kill all of us" whispered Ann, a girl in a wheelchair. I almost broke out in tears because she was absolutely frightened. So I told her, 'Don't worry, we're going to do something to protect you.' And I mean that," related **Bobby Schindler, brother of Terri Schiavo.**

Why would this girl worry so? Because it's here. For years pro-lifers have warned that abortion would eventually lead to euthanasia, the intentional killing of the disabled. The story of Terri Schiavo brought to the attention of the nation what has been becoming more and more acceptable across the nation, i.e., the withdrawal of food and hydration from the disabled, causing their death.
